**Requirements for Voter  
Registration in the  
State of Tennessee**

- ⇒ You must be a citizen of the United States.
- ⇒ You must be a resident of the State of Tennessee.
- ⇒ You must be eighteen (18) years old on/or before the next election.
- ⇒ You must have never been convicted of a felony, or have had your rights restored as required by law.

Giving false information to register to vote or attempting to register when not qualified is a felony punishable by not less than one (1) year nor more than six (6) years imprisonment or a fine of \$3,000 or both.

**VOTING BY MAIL**

If you are unable to appear at your polling place on Election day or during the early voting period you may request an absentee ballot be mailed to you for one of the following reasons:

1. out of town on election day and ALL days of early voting;
2. full-time student or spouse of student, outside county of residence;
3. caretaker of a hospitalized, sick or disabled person;
4. serving on a state or federal jury;
5. religious holiday;
6. candidate for office;
7. permanent absentee voting register;
8. you are 65 years of age or older;
9. you possess a valid commercial driver's license;

**YOUR REQUEST MUST CONTAIN THE FOLLOWING:**

1. Name
2. Address as registered in Coffee County
3. Social Security Number
4. Address to mail ballot
5. Election Preference—include party if applicable
6. Voter's Signature
7. Reason for request

Note: If you registered by mail you must vote in person for your first election.
